The Umpqua Community College Board of Education had a regular meeting on Wednesday, June 8, 2022, in Room 15 of Tap^hòyt^ha’ Hall at Umpqua Community College in Roseburg, Oregon; the meeting was live-streamed on YouTube. Board Chair Loosley called the meeting to order at 5:34 p.m. and the pledge of allegiance was given.

Chair Loosley recognized UCC Women’s Basketball Coach Dave Stricklin in attaining 900 wins during his 36 years of coaching. UCC appreciates Coach Stricklin’s dedication, commitment, and impact on many, many lives.

Introductions

- Tori Ruiz – Resource Navigator. Ms. Ruiz will assist students in applying for and accessing available local, state, and federal benefits and resources to help students overcome barriers. The Resource Navigator is also responsible for ensuring the provisions of HB 2835 are met.
- Joel Goodwillie – Winery Manager, Southern Oregon Wine Institute (SOWI). Mr. Goodwillie will manage the activities and services of the college winery and grow the presence of SOWI in the region.

REPORTS

Standing report:

- **President's Report – Rachel Pokrandt, Ph.D.:** Information was shared about the upcoming graduation; there are 454 graduates. Student graduation stories were shared. The Douglas County Sheriff's Office will deputize the UCC Chief of Security; this will allow him to be armed on campus. The current campus officer is retiring and there is no replacement available.

Informational report:

- **Pre-Apprenticeship – Robin Van Winkle, Dean of Community Education & Partnerships:** The Pre-apprenticeship program is for high school juniors and seniors who want to eventually enroll in a registered apprenticeship program. Completing students earn a certificate and have hiring preference. UCC received a grant for funding the program through June of 2023.

NEW BUSINESS

Resolution No. 17 – Adopting the Budget

The 2022-2023 Budget was developed through a transparent campus-wide process with the leadership of Natalya Brown, CFO, and Katie Workman, Budget Coordinator. The Budget has been reviewed in two public Budget Committee meetings that provided public input opportunities. Additionally, a Budget Hearing was held in May.

MOTION: I move to adopt the budget for the fiscal year 2022-2023 in the total of \$73,752,819, as presented. Motion by Dir. McDonald, seconded by Dir. Smith, and unanimously approved.

MOTION: I move to approve the imposed taxes provided for in the adopted budget at the rate of \$0.4551 / \$1,000 of assessed value for the operations and that these taxes are hereby imposed and categorized for the tax year 2022-23 upon the assess value of all taxable property within the district, as presented. Motion by Dir. McDonald, seconded by Dir. Smith, and unanimously approved.

Kelley Plueard, Director of Human Resources, requested Board approval to ratify the Salary and Employee Benefits portion of the ACEUCC Collective Bargaining Agreement effective July 1, 2022, to June 30, 2023. Changes were reviewed in Article 14 Compensation, Section A.1.; Article 15 Employee Benefits, Section A; and, Appendix A Classified Wage Schedule.

MOTION: I move to approve the changes to the ACEUCC Collective Bargaining Agreement, as presented. Motion by Dir. McDonald, seconded by Dir. Smith, and unanimously approved.

A summary of President Pokrandt's annual evaluation was shared. The president is reviewed annually with the goal of continual improvement which is an expectation of all UCC employees. The evaluation used the key presidential priorities of the past year and additional innovations and opportunities that

were capitalized on in the past nine months. Dr. Pokrandt's performance has been stellar over this time. The Board remains unwaveringly optimistic that by focusing on key areas for improvement the president will continue to engage the community and enhance student success in broader and more significant ways. The evaluation process also reviews compensation for the upcoming year.

MOTION: **I move to modify Dr. Pokrandt's contract for the fiscal year 2022-2023 as follows:**

- **Increase her salary by the average percentage wage increase of the full-time faculty, classified, and administration; and,**
- **Increase her retirement contribution by \$5,000/year to a total of \$10,000/year**

Motion by Dir. Kennerly, seconded by Dir. McDonald, and unanimously approved.

ORGANIZATION

The Board held their election of officers for FY 2022-23. An OCCA representative was not voted upon. Chair Loosley will cover the lobby/legislature responsibilities, or it can change as needed.

MOTION: **I move that the current positions remain the same, Steve Loosley as Chair and Guy Kennerly as Vice-Chair. Motion by Dir. Littlejohn, seconded by Dir. McDonald, and unanimously approved.**

Resolution No. 1 – Transfer of Water Right

President Pokrandt recommended Board approval of Resolution No. 1 to transfer the water right certificate 76681, owned by UCC at the Woolley Center, to the City of Roseburg. UCC has partial ownership of the certificate and there are limitations on UCC’s ability to use the water right:

- Most of the area of use of the water right is either paved or occupied by the building at the Woolley Center;
- The point of diversion is along the South Umpqua River which is land owned by the City. UCC doesn’t have the necessary easements to utilize the irrigation infrastructure; and,
- Because UCC is unable to show use, the water right is subject to forfeiture.

Because water rights are valuable property, the City has agreed to waive maintenance fees for the land around the Woolley Center, which amounts to \$4,056.00, for one year as compensation for signing over ownership of the water right.

MOTION: **I move to approve Res. No. 1, the transfer of water right certificate 76681 to the City of Roseburg, as presented. Motion by Dir. Richardson, seconded by Dir. Kennerly, and unanimously approved.**

<p>This is a resolution to increase appropriation in the Special Revenue Fund – Grants & Contracts.</p> <p>UCC has received the following grants and contracts from the State of Oregon/Oregon Department of Education</p> <p>Career Connected Learning Systems Navigator ends September 30, 2024 (Year 1 \$200,000) This grant provides support to UCC as part of a consortium with all 17 Oregon community colleges to hire a CCL Navigator to coordinate efforts to connect K-12 students with UCC Career Technical (CTE) programs and other career development opportunities, facilitate a network of professionals connecting schools, colleges, and employers and help design and implement systems that will drive improved opportunities for students across the state to find their passion, network with professionals, and successfully transition to a career or CTE program.</p> <p>Future Ready Oregon \$615,840 ends June 30, 2023 SB 1545 (2022 Regular Session) established a program in the Higher Education Coordinating Commission for the purpose of making grants to community colleges for the development of post-secondary career pathway training programs that provide individuals from priority populations with opportunities to obtain the necessary skills for securing a job or career advancement in high-wage, high-demand industries, and occupations.</p> <p>STEM Math \$83,790 ends June 30, 2023 This grant provides professional development and support to K-8 math educators to develop skills and instructional approaches that emphasize equitable practices that engage all youth to reach successful math outcomes. Your-long planning will result in an elementary and middle school math institute in the summer of 2023 based on local needs.</p> <p>STEM Innovation \$520,840 ends June 30, 2023 The UVSH Innovation grant supports the overall programming of the STEAM Hub in partnership with the state STE(A)M Network. The STEM Investment Council approves the statewide projects including Elementary STEAM Leaders, Early Learning STEAM Education, STEAM Transformation Schools, Computer Science/Digital Literacy, Career Connected Learning, Youth STEAM Ambassadors and Rural STEAM Leadership.</p>	

STEM Hub Backbone \$316,197 ends June 30, 2023

The UVSH Infrastructure grant supports the staffing of the Hub and essential operations. It also supports local STEAM initiatives such as the STEAM Extravaganza, the UVSH Lending Library and the Summer STEAM Institute.

GED Wrap Around \$62,040 ends June 30, 2023

To provide funding to support activities that will help increase GED® graduate numbers and connect those graduates to jobs or other post-secondary opportunities.

UCC received an award from the Oregon Community Foundation for STEAM Education in the amount of \$277,926 to support the work of Bright Futures Umpqua with a focus on Career Connected Learning. It will fund the operation of Expanding Horizons career summer camps and the mobile camp trailer as well as support youth driven projects to develop professional and leadership skills associated with successful careers.

UCC has received a 3-year grant from the US Department of Education (year one award is \$486,300) The Work-based Integration into Rural Education (WIRE) program is a federally funded grant aimed at helping rural students from middle school through college explore careers, navigate college processes, and connect with aligned work opportunities. The program will focus on recruiting and retaining students from Days Creek Charter School, Douglas High School, Elkton School District, Glendale School District, North Douglas School District, Riddle High School, and Yoncalla School District.

UCC has received \$40,000 from the American Association of Community Colleges to support the creation and implementation of a career pathway for AI mechanics and technicians.

UCC has been awarded \$30,000 from the Roundhouse Foundation to support supply purchases for Registered Nursing and Welding students.

UCC has received a 5 year grant (first year \$24,685) in partnership with the University of Oregon, from the National Science Foundation to increase the percentage of low-income students entering the Industrial Masters Internship Program at UO.
