#### **Citizen Comments**

Michael Lewis, ASUCC Business Manager, spoke in regards to the college budget. Mr. Lewis stated he is passionate about the college remaining affordable and cannot fathom any increase to tuition as students are paying at their maximum capacity. In good consciousness, he cannot ask the Board to increase tuition and fees, which is asking the poorest of the community to support the community. Chair Becker thanked Mr. Lewis for his comments.

#### Introductions

The Skills USA participants were introduced by Kevin Mathweg, Auto Instructor and Skills Advisor. Each student identified themselves, indicated their area of competition, and any awards received. Overall, about 30 post-secondary and secondary schools participated in the event.

#### **ASUCC Report**

Kristapher Yates, ASUCC President, appreciated the hardworking efforts of the ASUCC team while he was absent. Megan Morehouse, ASUCC Vice President, introduced the newly elected officers: Anthony

Terra, President-Elect, and Joshua Friedlein, Vice President-Elect. The Activities Officer will be Aria Blackwood. The Public Relations and Business Manager positions will be filled in the future.

ACEUCC Report – there was no report.

#### **UCCFA Report**

Marie Gambill, UCCFA President, said the Faculty Lecture Series received high commendations and it will be continued next year. The Association met earlier in the day and had a very positive meeting.

#### **President's Report**

Dr. Olson introduced Robert Johnson who is this year's Commencement speaker. Mr. Johnson is a successful UCC graduate who is now clerking for justices in Douglas County.

**OCCA Report** – Dir. Bell yielded his report to Andrea Henderson's presentation.

#### **Student Success Report**

Ali Mageehon, Dean of Academic Support, presented an update focused on tutoring which is one of the 25 Best Practices for Student Success. She provided a brief overview of Transfer Opportunity Program Tutoring and Student Success Center Tutoring. Ursula Angel, a recent UCC graduate, spoke about tutoring provided by the TOP program. She was able to "bloom" in her pursuits to attend the University of Oregon because of the TOP support she received. As a TOP tutor, she strives to build a relationship of support and empowerment to encourage, inspire and support the student. Maria Dresser works as a tutor in the Student Success Center. Students drop in for tutoring in math, writing, health & wellness, and psychology. If a student has taken a course and received an "A", they are eligible to tutor other students. The Success Center helps students achieve their goals. The tutors take ED 125 Foundations of Learning Assistance to develop cultural competencies for working with diverse students and understanding different learning styles.

#### **OLD BUSINESS**

Michelle Bergmann, Director of Financial Aid, provided an update on UCC's Cohort Default Rate (CDR). In reviewing a handout, Ms. Bergmann stated the 2010 CRD was 38.5% and the most recent draft-CDR is 30.3%; the goal is to have a CDR rate below 30%. The college has submitted data challenges and is working on loan servicer appeals in an effort to lower the CDR. Dr. Olson appreciated the effort put forth on this matter. Ms. Bergmann will notify the Board when the CDR rate is in the 20% range.

#### **NEW BUSINESS**

Andrea Henderson, Executive Director of the Oregon Community College Association (OCCA), provided an update on the OCCA and the legislative session. The state's \$535 million community college budget proposal is far short of what was requested by OCCA; it is an increase over last year's funding, but in reality it isn't even a restoration budget. Many community colleges around the state are making cuts. Ms. Henderson indicated the proposed bill for free community college tuition has created good conversation regarding affordable access to community colleges. An issue being addressed is the redesigning of the government structure for education, which includes the Oregon Education Investment Board and the Higher Education Coordinating Commission. Transfer policies between community colleges and universities are being reviewed to ensure there is no loss of credits in the transfer. Upcoming OCCA events include an orientation for new board members in July and the annual conference in early November.

Joyce Coleman, Vice President of Student Services, requested approval from the Board to increase testing fees. Responding to inquiries from the Directors, Ms. Coleman said it has been over two years since the fees were raised and non-UCC students take most of the tests. The tests include CLEP (an elective exam) in which other institutions charge \$65 and higher for similar testing. Some institutions, including UCC, require tuition in order for a student to receive credit from the tests. UCC facilitates the testing done on the computer.

# Motion: I move for approval of the testing fee increases for 2015 as presented. Motion by Dir. Bell, seconded by Dir. Yetter. Chair Becker, Directors Bell, Tamm and Yetter approved; Director Rice opposed. The motion was approved.

The Revised Budget Calendar for Fiscal Year 2015-2016 was presented for Board approval by Rebecca Redell, Chief Financial Officer. Ms. Redell highlighted the calendar changes.

#### Motion: I move for approval of the Revised Budget Calendar for Fiscal Year 2015-2016 as presented. Motion by Dir. Tamm, seconded by Dir. Rice and carried unanimously.

Ms. Redell presented Resolution #8, Approval to Transfer Appropriations in the General Fund between Instruction and Financial Aid in the amount of \$80,000. Responding to questions from Directors Rice, Bell, Tamm, and Yetter, Ms. Redell explained there were more UCC Scholars than originally anticipated and they had a high retention rate. Twenty-five UCC Scholars indicated they would have not attended UCC without the waiver. The college is required to book tuition and waiver as separate line items; there will be a net-zero in the end. Waivers for employees and their families are considered a benefit and are shown in a different part of the budget. Referring to the UCC Scholars, Director Bell said we have made a great investment in our students and have gained money from the state; this is good since retention and graduation is our goal.

#### Motion: I move for approval of Resolution #8, Approval to Transfer Appropriations, as presented. Motion by Dir. Rice, seconded by Dir. Yetter and carried unanimously.

Resolution #9, Approval to Spend Funds, was presented by Ms. Redell. The resolution is to increase appropriations in the Special Revenue Fund – Grants and Contracts. Anya Petersen-Frey was awarded \$2,000.00 from the Ford Family Foundation to support the Startup Weekend Roseburg event.

Motion: I move for approval of Resolution #9, Approval to Spend Funds, as presented. Motion by Dir. Tamm, seconded by Dir. Rice and carried unanimously. College Board Minutes May 13, 2015

Lynn Johnson, Director of Human Resources, requested Board approval for Beverly Jensen, Nursing Instructor, to receive Early Retirement benefits effective October 1, 2015, in accordance with the Memorandum of Agreement between UCC and UCCFA. Ms. Jensen will conclude her career at UCC with 13 years of service.

#### Motion: I move for approval of the Early Retirement Request from Beverly Jensen, as presented. Motion by Dir. Yetter, seconded by Dir. Tamm and carried unanimously.

Ms. Johnson requested Board approval to authorize the college to develop an action plan for a reduction in force. Dir. Tamm clarified this request as just authorizing the college to prepare a plan and the plan will be brought back to the Board for approval. Chair Becker said this was discussed in an executive session and individually. She thanked the faculty and staff who had communicated to her.

### Motion: I move for approval for the college moving forward to develop a plan for Reduction in Force, as presented. Motion by Dir. Tamm, seconded by Dir. Rice and carried unanimously.

#### **Board Comments**

- Dir. Rice attended the Merry Lives of Windsor High at the college; it was a fabulous show.
- Chair Becker thanked everyone for their patience as the Board has been working through budget realities.
- Dir. Bell introduced audience member Doris Johnson-Lathrop who is running for the Zone 2 Board position.

# Board Report Instructional Services June 2015

## Dr. Roxanne Kelly, Vice President for Instruction:

- Umpqua Community College hosted the Council of Instructional Administrators on May 14<sup>th</sup> 15<sup>th</sup>. A large part of the meeting was regarding the relationship between Community Colleges and k-12 partners as well as building relationships with our university counterparts. A great deal of valuable information was gathered from the meeting.
- Leadership UCC graduation was on June 5<sup>th</sup>. There are 10 participants who will be completing the year-long program.
- Continuing to preparing for the year seven Accreditation visit in October. The accreditation committee has been hard at work writing to the accreditation standards as well as compiling exhibits.
- Continued participation on the Bonnie J. Ford Health, Nursing and Science construction team. The color scheme and design elements have been chosen with some refinements to follow.
- On May 27<sup>th</sup> I was installed as the Zonta Club of Roseburg president for 2015-16.
- I participated in the annual Outstanding Student Reception event. It is always a privilege to be a part of the celebration of student's successes.

Science:

• The UCC Instructional Council has just approved a new Associate of Science degree in Natural Resources developed by the Science Dept. in collaboration with OSU's College of Forestry to articulate with their Natural Resources Bachelor of Science degree. Discussions are currently under way with the Engineering Dept. to collaboratively develop two new OSU-articulated Associate of Science degrees in Forest Engineering and Forest Management.

# Dr. Ali Mageehon, Dean of Academic Support:

ABS:

- Lindley Ballen planned the Woolley Center Learning Garden Fundraiser "Garden Party" on May 7<sup>th</sup>. It sold 30 tickets and raised \$449 in silent auction items.
- Robin VanCleave organized the spring College for a Day event on May 7<sup>th</sup>. We hosted 45 students—and were supported by multiple departments on campus, including the Success Center, Scholarship Office, Advising and Counseling, Financial Aid, Peer Mentors, ASUCC, TOP, Science, and many ABSD faculty
- Instructor André Jacob has led and participated in three days of volunteer opportunities for ABSD students. On April 18, 10 students volunteered for Earth Day. On May 16, 14 students volunteered for the United Way Day of Caring, and on May 29, 10 students volunteered to work at the Hershey's Track Meet.
- On May 13, Director April Hamlin attended the Career Pathways Alliance spring meeting in Salem.
- On May 18, April Hamlin attended the WIOA Workgroup at Clackamas Community College and on May 19 – 21, April Hamlin attended the Oregon Council for Adult Basic Skills Development Fall meeting.
- On May 29, the Adult High School Diploma Local Plan for 2015-2016 was submitted to CCWD for approval.

Success Center:

- Coordinator Tyler Ramos and Director Snyder have been collaborating across campus to develop a summer skills review, which includes multiple disciplinary technology. This will course will be offered at no cost to students. Continually, there is a high interest for students and significant contributions being made by the Reading, Writing, and Math areas on campus.
- Coordinator Tyler Ramos attended a Supplemental Instruction conference from May 25-28th at Texas A&M University.
- Brent Lewis and Kari Moore are attending an Acceleration in Developmental Education conference in Cosa Mesa, California at the end of June.
- Dean Ali Mageehon and Director Ethan Snyder are collaborating with Student Services regarding first-year experience and learning skills courses in support of UCC Scholars.
- Dean Ali Mageehon and Director Snyder are actively working with Director Carol McGeehon and Vice President Roxanne Kelley in creating an implementation plan for the Learning Commons on campus. This project is being supported through Title III funding.

Educational Partnerships:

• UCC Faculty and Douglas County ESD CTE Teachers met to complete Perkins Reserve Projects for the year and co-construct proposals for 2015-2015. The group is working

together to increase non-traditional participation and completion in Career and Technical Education.

- UCC CTE Faculty and Student Services staff submitted their proposals to the Perkins committee. The proposal will be written and submitted to the state next month.
- Reynold Gardner from ODE met with Educational Partnerships, Welding, Business, and Viticulture representatives to consider joining the Statewide Perkins Program of Study for Agriculture, made possible by Bill Armstrong's newly developed agriculture program.
- Kristi Hurt, Educational Partnerships Specialist, attended a statewide Career Pathways Network meeting and is working to update all Career Pathways Roadmaps.
- Joan Campbell attended the statewide Dual Credit Coordinators meeting. The group is looking at pre-requisites for participation in dual credit at all 17 community colleges with the help of EdNW.

UCCOnline:

- Joan Campbell attended the spring quarterly meeting of the Oregon Community College Distance Learning Association (OCCDLA). The group approved the 2015-2017 biennium budget proposal to be submitted to CCWD. Joan was elected co-chair of the biennium and selected as one of two delegates to attend the Instructional Technology Council's Leadership Academy this summer in Denver.
- UCCOnline has hosted three drop-in labs per week for faculty.
- All fully online classes are now in progress moving to Canvas.
- UCCOnline and the Library hosted Amy Hofer, OCCDLA's Open Educational Resources (OER) Librarian, for an informative student lunch meet-up followed by a faculty workshop. Both Science and Adult Basic Skills have recently adopted OER textbooks, providing immediate relief for students in textbook costs.

JOBS:

- The Business Plan was submitted to the Department of Human Services (DHS) for review and approval.
- The Financial Specialist position was posted and closed May 18<sup>th</sup>.
- DHS invited JOBS staff to attend trainings held by Doug Eckstein, LPC, of Valley View Counseling. Trainings will cover the neurobiology of attachment, vicarious traumatization, and reading and understanding psychological evaluations.

# Jesse Morrow, Dean of Career Technical Education:

- Continuing to work on the Health, Nursing and Science Center building committee
- Attended CIA meeting on May 14<sup>th</sup> at UCC Lang Center

Apprenticeship:

- Apprenticeship Coordinator did coast visitation trip to connect with students and employers in Coquille, North Bend, and Brookings. A time of facility tours and strengthening communication with students and employers. Positive/productive outcomes!
- Met with Southwestern Oregon Community College staff and discussed each class within the curriculum as to best format for student to receive: live class at SOCC, distance format from UCC, or TPC training (book self-taught). In depth discussion regarding logistics of classes offered via distance format, especially hands-on segments (lab work).
- Interviews for inside electrical program scheduled for June 10th

Automotive:

- The automotive program is getting prepared for the separation of the general auto program from the T-TEN program.
- The general automotive program will use several certifications and increased training material from their industrial partner, Snap-On Education. Several automotive dealerships and private automotive repair facilities have expressed an interest in working with the program through cooperative work experience and hiring graduates.
- The T-TEN program is continuing to place qualified students into Toyota dealerships. The Students will be part of the new T-TEN program where they will be alternating every term between working at the dealerships and training at UCC. At the completion of the two year program, the students can obtain an associate degree as well as certification through Toyota.

Community & Workforce Training:

- HB 2410 has been passed by the Oregon Legislature and is awaiting the Governor's signature. This bill allows Community Colleges to offer non-credit Training Certificates to assist students in gaining entry level and upgraded work skills.
- Four staff members attended the Oregon Association of Community & Continuing Education Spring Form in Redmond. The featured speaker was Greg Marsello, LERN's VP of Organizational Development. Greg is a national authority on reengineering management and running continuing education programs.
- Ronda McClure was named the 2015 Community College Community Educator of Year at the Spring Forum for her programming work in lifelong learning.

Dental Assisting:

- The dental assisting students and staff have had a wonderful experience with the Campus Smiles Project. Over 50 sets of bleaching trays were made for UCC students. The dental assisting students all agreed that the practical experience of working with live patients was invaluable. The students who were the recipients also seemed to have a positive experience. Dr. Alanson Randol and Dr. Kimbrough will visit the lab on May 27th and June 3rd to supervise delivery of the bleaching trays and enable the students to earn check offs for their EFDA certification.
- All 20 students are on track to graduate. The students will have the opportunity to share their accomplishments with their families and friends during the Dental Assisting Pinning Ceremony on June 10th at 6pm at the Danny Lang Teaching and Event Center.

# EMS:

- In Fall of 2014, the EMS department started using an online program for testing in the classroom. The program allows students to take their exams for class in a format similar to what they will see when taking their National Certification Exam. The program also allows the students to practice taking Computer Adaptive Tests that mimic what they will see on the certification exam. At the end of spring term, 17 students completed their EMT course. To date, 13 of those students have taken and passed their first attempt at the National Certification Exam.
- Enrollment appears to be on an upswing as there are 16 students in the EMT course that started Spring Term. Two years ago we had to cancel the class and last year, there were only six.

# Engineering/CIS Department:

• Proposed Degrees in Forestry Management and Forestry Engineering. The UCC Engineering/CIS Department is proceeding forward with development of an AS degree in Forestry Management and an AS Degree in Forestry Engineering. Courses from the UCC engineering program, UCC general education courses, UCC math and science courses, and the core forestry courses being offered for the new Natural Resources degree, will all provide the frame work for the proposed degrees. The UCC engineering program has been in contact with the OSU College of Forestry and it appears that the proposed AS degrees in Forestry Management and Forestry Engineering degrees was approved by the UCC Instructional Council (IC), and IC approved further curriculum development and feasibility study. If the AS degrees in Forestry Management and Forestry Management and Forestry Engineering are determined to be feasible, the degrees will be offered in 2016/17.

# Fire Science:

- Fire Science is now taught on three high school campuses. SUHS has offered a dual credit program for fire science for two years. Sutherlin and Douglas High Schools are finishing the first year of the Expanded Options Program. Next year, Fire Science will be offered at four area high schools as Glide is planning on starting Fall term.
- Fireblast Fire Simulator is now at Glide Rural Fire District. The yearly maintenance has been completed. All systems working great. Corrosion identified and pictures sent to Fireblast for resolution determination.
- Approximately 170 students thus far have attended Wildland Firefighter Refresher training.
- Attended FESHE meeting in Coos Bay May 8, 2015. Program modifications are needed to bring UCC Fire Service more in line with the national models

# Welding:

- Current focus is on community involvement, growth, student support, and job placement.
- Implementation of programs regarding small parts fabrication and production with Fab-Form and Great Northern Trailer companies are currently in place and continue to develop. This has led to several jobs for the welding program graduates.
- Working with Wilson Biochar Associates on a 2 year grant to produce Biochar Kilns for soul amendment purposes. The project will target local agriculture and timber industries in the production of char to improve soil composition.
- The welding programs development of new classes and Associate's degree is now official, as the 2015-2016 UCC catalogue has been issued. We are looking forward to serving more students and delivering more certifications at higher levels of skill within the production, manufacturing, fabrication, and pipe welding industries.



## Summary of support to students in order to meet objectives of Good Academic Standing/ Persistence/Graduation/Transfer:

- The Director and Advising specialist visited all the high school TRiO UB/ETS programs with current college students to discuss some of the changes from high school to college.
- Six (6) TOP students interviewed for Ford scholarships. Three (3) TOP students were selected for Ford Scholars and one (1) for Ford Opportunity.
- Two (2) TOP students were awarded the All Oregon Academic Team medal in Salem at the Governor's office
- One (1) TOP student has been selected for a Jacoby finalist.
- The TRiO staff has written and submitted three small sub-grants. We have submitted 2 grants to ASUCC requesting funding for our textbook loaning library, Echo pens for students with learning disabilities, and a Funds for Innovation grant through the Foundation to begin a summer bridge program summer 2015. We were awarded the Echo Pen grant and await response on the other two.

#### Ford Childhood Enrichment Center - Nora Bing, Director

- As we come to the end of our spring term, we continue to grow in all ways here at the Ford Childhood Enrichment Center. Garden vegetables have been planted and are starting to grow. The children have spent the last week studying bugs and watching ants create trails and tadpoles become frogs.
- Registration has begun for both summer and fall terms. This summer we are pleased to begin offering
  swimming lessons to our 3 5 year old students. It is great to collaborate with our physical education

## **Financial Aid Awards**

Disbursements for the 2014-15 award year through 5/27/2014 total over \$8.2 million to 1,856 students in Grants, Loans and Federal Work-Study. This does not include outside sources such as Veteran's benefits or UT&E.

- The 15/16 financial aid year is in full swing and students are submitting documents daily. We are currently awaiting a Banner update to begin awarding and expect the update this week. With the improvements, we have made this past year; we currently have 465 students ready to be awarded.
- We are still awaiting the results of our Loan Servicer Appeal for the 2011 Cohort Default Rate.
- Currently we are sitting at 30% for the 2012 Cohort Default Rate, and it looks very promising that we will be under the 30% mark to avoid sanctions. The final rate is not due until September 2015.
- Our office is working with ECMC regarding a default management dashboard that would greatly assist our staff with managing UCC's default rate, in an effort to keep our future rate below 30% at a lower cost to the college.
- Our office is encouraging the UCC campus community to become aware of SALT and all that it has to offer our students. A SALT advertisement is currently on the UCC website and a two (2) minute video has been added to the Financial Aid webpage to assist in creating awareness. Flyers, banners and visuals on campus are other means being used to create awareness
- Three UCC staff members and a UCC veteran attended a SALT forum at the University of Oregon.
- As Audrey Brown has made a lateral position move to the Finance Office, we are in the process of hiring her replacement as Financial Aid Assistant.
- Brian Proctor will be graduating from UCC Leadership on June 5<sup>th</sup>; we are very proud of him.
- There have been several 15/16 Financial Aid Literacy Seminars (FALS), on campus presentations including Saturday presentations in conjunction with the Advising and Career Centers NSO New Student Orientation. The online FALS seminar still in the update phase but remains available to students as an option.

## Accessibility Services, Danielle Haskett

Accessibility Services was the recipient of five Echo pens as a result of a service learning class project for Small Group Discussions. The project was coordinated by Evelyn Barry, Lauren Jaworski and Scott Nicholson. The pens write, record and replay content that students' learn in class. They are a resourceful assistive technology tool that contributes to student success in class. Accessibility Services purchased a cart using Student Success funds that will be used to transport students on campus that have mobility impairment. The Mini Taste of Technology Resource Fair sponsored by the Oregon Relay hosted an event on campus that Accessibility Services attended. Accessibility Services attended Roseburg High School for two days and will be presenting to a group of high school students from Oakland. Students' receiving accommodations for spring term have increased to eighty-seven and we are gearing up for finals week testing accommodations.

## High School Connections/Recruitment Specialist, Kira Oerman

Educational Talent Search:

#### Foundation General Board Meeting

The Foundation Board will hold its next General Board meeting on September 8, 2015 in the Lang Center at 11:30 a.m..

#### Health, Nursing & Science Capital Campaign

A groundbreaking ceremony was held on May 15, 2015. It was attended by about 125 people including many Foundation Board members, college staff and donors. Michael Stanley, Bonnie Ford's son made a nice presentation. OPSIS Engineering provided information about the new Health, Nursing and Science Building in the lobby of Jacoby Auditorium. Construction will commence on June 15, 2015 and conclude in September of 2016.

We have just sent \$3,400,000 in funds from the capital campaign to Ferguson Wellman for investment in bonds at the request of UCC's Business Office. It will generate modest income until the college needs to funds to pay a balloon payment on its loan in four years. Gratitude to Ferguson Wellman for waving any fees on this transaction on behalf of their company.

#### **Scott Henry Dedication Set**

The dedication of the Scott Henry Vineyard encircling the front of the Danny Lang Teaching, Learning and Event Center will be held at 3:30 p.m. on Wednesday evening, June 3, 2015. Each of you and your family and friends are invited to this special opportunity to recognize Scott Henry for his amazing contributions to our wine industry and especially to the development of the Southern Oregon Wine Institute.

We will have some food and wine afterwards in the Lang Center. Henry Estates Vineyard is launching a new wine label and we will be pouring several of their newest wines.

#### **Development Review for UCC Foundation**

We have received a ninety page draft from Mike Gaudette, the Foundation's Consultant. We are looking through many options and prioritizing them as we proceed forward. Mike has offered great admiration for the structure and level of work that we have accomplished in our Foundation Office and commends our "outsized" contributions to UCC and Douglas County.

Mike stated that our organizational model for the Board and staff are unique and yet highly efficient at reaching and maintaining effective communications with all donors to the college. Mike noted that our capital campaign planning and execution are especially impressive and most other community colleges would covet similar outcomes.

#### **Grants Office**

Since February, UCC and the Foundation have submitted 11 grant applications totaling \$161,636. Applications include a wide variety of projects including scholarships, Oregon Music Theatre Festival, child care subsidies, HNS Center, AmeriCorps members, RICH Project, Startup Weekend, and Oregon One Acts.

#### Planned giving website

The new planned giving website is online connected to the UCC website, but the direct link is <a href="http://umpqualegacy.org">http://umpqualegacy.org</a>. The website offers donor stories, gift options, guides to will planning, and gift calculators. This is the first step in launching a comprehensive planned giving program, which will include marketing materials and community presentations soon.

#### Fund for Innovation

The UCC Foundation released a request for proposals to the UCC community for grant funding from the Fund for Innovation. Grant applications will be accepted by May 7<sup>th</sup> from UCC programs and groups to implement innovative projects, and will be reviewed by a panel of UCC Foundation board members. Awards will be made in June.

#### Projects and partnerships in the making

Multiple projects and partnerships have been rising to the surface as the need for external funding increases. Some exciting projects and partnerships we have been collaborating on include:

- Retail management pathways certificate grant through the Walmart Foundation and Achieving the Dream with a team from the business department
- Observatory and astronomy outreach program with the science department

- Umpqua Makers Guild possible partnerships with community, SBDC/UBC, and business department
- Centers of Excellence for Veteran Student Success grant from the U.S. Department of Education with a team from student services


