1. Overall Enrollment Comparison 2017-18 to 2018-19

Noting that winter term 2019 has not yet ended, and that there is outstanding data for that term, the following table compares student headcount by student type for summer, fall, and winter term in each of the two academic years. Total student headcount for winter term 2019 will increase after the term closes and its CE enrollment data is copied from the CWT system into Banner.

2. Budgeted Enrollment Number

UCC's Chief Financial Officer, Natalya Brown, provided clarification on how we budget student enrollment.

We are not budgeting student enrollment based on FTE but rather based on credit hours. For this fiscal year 19, we used flat credit hours from the year before and additional athletic enrollment. It is not realizing however. Tuition is tracking about \$110,000 below of what we budgeted for this FY. For instructional credit fee we didn't have historical data as it is a new fee this year and we used same assumption as for tuition. The instructional credit fee is tracking about \$35455 under the estimated amount. We are currently reviewing projections for next year because of it - we will need to adjust our revenue down...

3. Numbers Reported to HECC

Attachment #1 shows the final data UCC reported to HECC for academic year 2017-2018. Attachment #2 shows the data reported to HECC to-date for academic year 2018-2019.

4. Enrollment by Declared Program of Study

Attachment #3 shows, for each program with at least one student, the number of students who have declared themselves to be pursuing that program of study. It is common, though, for students to change their program of study without informing the Registrations and Records office. In those cases, the

students appear in the wrong count. A good example of this is the student shown in C-AV (Aviation Flight Technology), a program UCC no longer offers.

5. Description of Modifications to Enrollment Reports

Since June 2018, the Comparative FTE and Enrollment reports have been modified in the following three ways:

1. **Data for courses assigned to state activity code 211, Career/Workforce Standalone, now appear on the reports.** Career and Workforce Training determined that several of their course offerings, previously assigned to a different code, should be in code 211.
2. **Charts have been added for a visual comparison of current to previous year data.** Previously, a “summary box” was the only visual aid to interpreting the data in the reports. While helpful, the summary box only captures one week. The charts display data for the entire term.
3. **The report publication schedule is now once per month, the week prior to Board of Education meetings.** Depending upon the number of terms open for reporting, creating the reports requires two to four hours of Institutional Research time. Dr. Crabtree recommended to President Thatcher that the weekly reporting schedule be changed to a monthly schedule, both to reduce the amount of IR time invested in creating these reports, and to help alleviate reporting inaccuracies caused by variations in the timing of UCC business processes from year to year. President Thatcher agreed with the recommendation to move to a monthly schedule. For data continuity, IR still collects the report data weekly, but this process only requires about 30 minutes to complete.
