It's the first term of the biennium, so we had Natalya, Katie, and Craig discuss some of the UCC budget. Community Colleges statewide received a combined \$647 million dollars. However this was still not quite enough to help keep costs low, so the recommendation was to provide a 3% increase in tuition. \$3 per credit increase, with \$1 per credit increase for instruction fee. Athletics has continued growing with more concentrations of more sports. Due to this, they are looking at adding a \$1 per credit increase to athletics programs to help fund those programs. This is potentially including free student access to the fitness center, and possibly pool access.

This proposal is being created for December for a Summer 2020 implementation. We talked about the housing option that is owned by UCC, and noted it should be opening very shortly. Max occupancy is 60, but to be comfortable 45 students are desired. We also discussed legacy fees on our costs, which are those that help pay for the newer buildings. This is planned to be carried over year-over-year to help with upkeep.
