## Other things to think of:

**Tuition cost** is \$109 per credit with a \$14.50 **Student Resource fee** per credit, an \$8.00 **Legacy fee** per credit and a \$7.00 **Instructional fee** per credit for a total of \$138.50 per credit. Additionally, the **average fee** costs are \$25.50 per term. **Budgets are based on 13 credits per term**. Adjustments to tuition and fee costs must be made to reflect additional tuition costs for out-of-state students. **NOTE**: 4 Term budget based on 8 week Summer term. Subject to change if attending only 4 week Summer Session.

## **BUDGET ADJUSTMENT CIRCUMSTANCES**

**DISABILITY EXPENSES** - may be added for documented costs that are not covered by other assisting agencies.

**CHILD CARE EXPENSES** - \$1,990 per child (birth to 12 years old), per term with completion of Child Care Cost Add-On Worksheet. Based on Department of Human Services Child Care Rates.

**DIRECT LOAN FEE** - an average \$50 loan fee will be added to the budget for students requesting Direct Loan assistance to accommodate the 1.057% loan origination fee.

## FINANCIAL AID AWARDS THAT ARE REDUCED PROPORTIONATELY FOR LESS THAN FULL TIME ENROLLMENT STATUS:

- Pell Grant (PELL)
- Supplemental Education Opportunity Grant (SEOG)
- Oregon Opportunity Grant (OOG)

1-5 CREDITS= LESS THAN HALF-TIME STATUS
6-8 CREDITS= 1/2 TIME STATUS
9-11 CREDITS = 3/4 TIME STATUS
12+ CREDITS = FULL TIME STATUS

Students attending Less than HALF-TIME status for all terms will have Room & Board and Personal removed from their Cost of Attendance.
